Dear Provider:

Kentucky is one of 35 states that participate in the National Core Indicators. NCI was awarded a contract from the Administration on Intellectual and Developmental Disabilities (AIDD) with the goal to increase participation to all 50 states and District of Columbia within 5 years.

This is our fifteenth year of involvement in an effort to measure the quality of developmental disabilities services in Kentucky. This involves conducting interviews with a random sample of individuals and their families. We are again relying on the interviewers contracted through the Human Development Institute (HDI) at the University of Kentucky to obtain consent and complete the surveys for those who are randomly selected.

We ask that you assist in the process by completing the pre-survey and background information on each individual you serve whose identification is located on the label in the upper right hand corner of the blank pre-survey. We are not asking you to obtain consent for the pre-survey or the interview. That will be done by UK interview staff.
